TESTING 2005+ CNG VEHICLES

In Tech Bulletin 2008-2 we discussed testing 2004 and older CNG vehicles using bypass code 201. This procedure still applies but may not be used on 2005 and newer vehicles.

Federal law requires all CNG vehicles model year 2005 and newer to be 100% OBDII compliant. Only EPA or CARB certified conversions may be performed on these vehicles. Installing a non-certified conversion kit on one of these vehicles violates the Clean Air Act and is considered tampering.

An inspector may verify a certified conversion by the supplemental emission control label that the installer is required to permanently affix near the original emission decal. This decal will verify that the vehicle complies with federal emission requirements, as well as identify the vehicle's model year and engine family, who the conversion was performed by and what fuel the vehicle was converted to use. Factory CNG vehicles may only have one emission label but it will identify the vehicle as CNG and conforming to USEPA OBDII emission requirements. If no label is present an EPA certificate of conformity or CARB

executive order letter clearly matching the vehicle may be substituted. If no documentation is provided by the vehicle owner the vehicle should be failed for <u>ALL</u> visual tampering components on the inspection report and referred to the technical center.

We are more than willing to assist the vehicle owner in locating copies of the conversion documentation if it exists. However, there will be no alternative test procedures for these vehicles and there will be no waivers granted to non certified vehicles.

VIN numbers on 2010 + models

It's 2009 already and the 2010 model vehicles will be released before we know it. Some technicians have asked how the 2010 models will be identified by VIN. The vehicle identification number will remain a 17 character unique identifier for all vehicles. The 10th character will continue to identify the model year but will change to an alpha character for 2010.

Besides the three letters that are not allowed in the VIN itself (I, O and Q), the letters U and Z and the digit 0 are not used for the year code. Therefore, A = 2010, B = 2011, C = 2012, etc. The VIN check digit will help differentiate a 2010 model from a 1980 model which both use an "A" for model year designation.
