HB 70 - CNG VEHICLE CONVERSIONS

On July 1, 2010 HB 70 went into effect resulting in minor changes to the testing procedures of CNG vehicles. This Utah bill removed the requirement that CNG conversion kits be EPA certified. This new State Law is in direct violation of Federal Law so we'll have to wait and see how this all plays out.

While this law is in effect inspectors do not need to verify EPA certification on CNG conversion kits. Other than certification requirements the testing has not changed. Tailpipe testing on 2004 and older vehicles (bypass code 201) and full function OBDII testing on all 2005 and newer vehicles. 2004 and older bi-fuel vehicle must be tested on both fuels.

UTAH2011 UPDATE

As 2010 winds down we're still not sure what direction the Utah County I/M Program will be going in the future. Salt Lake County has had a series of setbacks during their contractor selection process and currently does not have a contract signed for their new program scheduled to be implemented in April 2011.

The realty of the situation remains that Utah County will need to make program/equipment changes in the near future. At this time we have all options open to us and will hopefully be able to make a decision some time next year. Our goal is to provide station owners ample time to prepare for these changes after our direction has been determined.

TECH TIP # VE0051

EGR blocked off on 2000 Nissan V6 Xterra or Frontier

Both Motor and Mitchell application manuals indicate that all 2000 Nissan V6 Xterra and Frontier vehicles are equipped with an EGR system.

However, a bulletin directly from Nissan states that vehicles built on or after October 6, 1999 no longer use an EGR valve. The intake manifold port formerly used by the EGR valve is now covered with a blanking plate.

If you are testing one of these vehicles you may disregard the application manual and enter NA for EGR.

If you need to replace the ECM on one of these vehicles be sure to get the right computer for the vehicle. Installing an early computer on a later build vehicle will result in MIL illumination.
