Diesel Emission Inspection

The Utah State Legislature passed House Bill 101 requiring Utah County to emission test diesel fueled vehicles. Utah County adopted an ordinance implementing the required testing. Listed below are important details.

- Testing will begin January 1, 2019.
- All stations and technicians desiring to participate in the Utah County Emissions program will be required to inspect diesel fueled vehicles.
- **All current technicians** will be required to attend and pass training on diesel testing as a condition of renewal for 2019. Available training dates and times are listed below.
- All required model years will have a visual tampering inspection and 2007 to current will also require an OBD test.
- Programmers if present, will be required to be EPA or CARB approved.
- Your current emissions analyzer will be updated to test diesels also.
- Vehicles missing the emissions label will require replacement of the label.

Diesel Vehicles Requiring Testing

- All "on road" diesel vehicles with a manufactures gross vehicle weight rating of 14,000 lbs or less and;
- Diesel vehicles model years 1997 and newer (five latest model years will be exempt ie: 2015-2019).

Diesel Update Class


All currently certified technicians must obtain the training and pass the final with 80% or better.

- Classes will be at Utah Valley University, Computer Science building- Room CS404.
- Parking will be free in the lot near the Computer Science building. (After 5:00PM).
- Cost for the training is \$8.00 per technician. (Payment made to UVU)

- Any current technician failing to obtain training will need to re-certify prior to renewal for 2019.
